THE IMPORTANCE OF SELF SCREENING

The self screening guidelines are set are to:

- a) ensure that the training being offered is a correct fit for you and;
- b) to ensure the high caliber of professionals that will be associated with you as colleagues;
- c) to bring credibility to this growing field of study and most importantly;
- d) to maximize professional safety and value for the clients who will be seeking your services in the future.

For this skill set, you will need to have a minimum of 2 years experience in a healing or helping field with considerable existing experience with clients. We ask that you are responsible in deciding whether or not you have enough personal and professional experience to learn the foundation skills of how to facilitate a medical intuition scan and deliver it in a professional manner to clients. We are looking for practitioners who have enough experience with their own self growth to be able to truly empower clients by using this style of medical intuition for information gathering only, versus offering healing recommendations. Once you have learned these foundation skills you are encouraged to weave and blend them into your existing services in a way that is unique to you. You need to realize that although it is inevitable that you will experience personal growth throughout the classes, the training itself is not a therapy tool for you, it is a learning setting.

Many practitioners have reported that they have needed to do some restructuring of thought and approach to practice this work effectively. Many who work with healing modalities have reported that they need to remind themselves not to work in a healing capacity while they are receiving information from the body in the scan. Many people who are highly skilled practitioners find it difficult to remind themselves to “check their maps & modalities” at the door, as existing practitioner’s healing modalities are not a part of this type of foundational attending style work.

Perhaps the following questions may help you decide if the training is for you at this time:

- Have you worked with clients in a professional capacity for more than 2 years?
- Do you have a process in place and experience with your own self reflection, growth and healing?
- Can you recognize and allow the client to be the expert on themselves and be responsible for themselves?
- Could you live with the fact that the client is the expert on them, rather than you being the expert?
- Have you read, experienced, or considered that there are realities and energetic principles that exist that perhaps we currently cannot see nor understand?
- Have you found a way to bring the energy of love as opposed to that of fear into your own personal life in a balanced fashion?
- Are you open to learning a new way of working or even thinking to integrate into your existing practice and philosophy?
- Are you willing to be responsible in encouraging others to seek the healing resource support they need beyond the tools you will be providing?
- Do you have a foundation knowledge of basic anatomy & physiology?
- Are you grounded, healthy and functioning at a relatively positive level in this amazing roller coaster world we all live in?
- Can you operate professionally with a fair bit of independence, confidence and autonomy?
- Are you willing to take the initiative that is required and expected in an adult learning setting?
- Are you interested in being recognized as a professional within a growing field that uses tools that access information and insight at a highly energetic level?

If you have answered “YES” to more than 8 of these questions then likely you will enjoy and gain professional benefit from the training. If you have answered “NO” to more than 3-4 of these questions perhaps this type of training is not for you at this time or we need speak in person to clarify some of your personal or professional beliefs that may interfere with you getting the most out of the training being offered.
